- (2) Recognition and comments from guests:

Sharon Berry commented on the purpose of the Covid Grant monies and why the polling locations were lacking equipment. *this was not on the agenda so no discussion or action was able to be taken

- (3) Commissioner Lovell moved to approve the Commissioners Court minutes from June 23, 2020 and June 26, 2020. Commissioner Henderson seconded. Motion carried 3 to 0.

- (4) Consider approving budget amendments. None
- (5) Consider payment of bills and expenses:
 - a. Accounts payable
 - b. Fund transfers
 - Ratify Salary expenses
 Commissioner Lovell made a motion to pay all of the bills and expenses for a.
 (Accounts payable), b. (Fund transfers), and c. (Ratify Salary expenses). The motion was seconded by Commissioner Henderson. The motion carried 4 to 0.
- (6) Receive information, announcements and reports from County Departments:

 Commissioner Henderson made a motion to receive as information the
 Environmental Report. Commissioner Loveli seconded. Motion carried 4 to 0.
- (7) Consider approving salaries for new and/or transfer employees:

 (a)Commissioner Lovell made a motion to approve Candi Reid for Part Time Dispatcher
 Position with the Sheriff's Office, Pay Grade 15 and Hourly Salary of \$13.37. Commissioner
 Kitchen seconded the motion. Motion carried 4 to 0.
 - (b)Commissioner Lovell moved to approve a 6 month raise for Jennifer Pierce the District Deputy Clerk at a bi-weekly salary of \$1101.84. Commissioner Kitchen seconded. Motion carried 4 to 0.
 - (c)Commissioner Henderson moved to approve a 6 month raise for Belinda Hinson the County Deputy Clerk at a bi-weekly salary of \$1156.94. Commissioner Lovell seconded. Motion carried 4 to 0.
 - (d)Full-time Deputy Sheriff *PASS
 - (e)Commissioner Kitchen moved to approve Larry Walker as Part time road hand for Precinct #2 at pay grade 13 and hourly wage of \$11.55. Commissioner Henderson seconded. Motion carried 4 to 0.
- (8) Discuss and consider approving payment of compensatory, and vacation time for County employees and necessary budget amendments. None

- (9) Commissioner Kitchen made a motion to amend the contract with EForce/Intellichoice for Computer-Aided Dispatch (CAD) software at the Houston County Sheriff's Department to Increase to unlimited view-only user licenses for a fee of \$5,000 and an increase in annual maintenance of &750.00. Commissioner Henderson seconded. Sheriff Killough said the necessity for this increase is we are in excess of the amount of allotted users and this will make it unlimited. Motion carried 4 to 0.
- (10)Commissioner Lovell moved to appoint Lois Ball for another term as Burke Center representative for Houston County. Commissioner Henderson seconded. Motion carried 4 to 0.
- (11)Commissioner Kitchen made a motion to approve transfer of one airport hangar lease from Mark Whitfill to Gordon Shaw. Commissioner Henderson seconded. Motion carried 4 to 0.
- (12)Commissioner Kitchen moved to approve the amendment to the Airport Hangar Lease Agreement executed by Mark Whitfill for transfer to Gordon Shaw to become effective upon the execution of agreement by Gordon Shaw and County Judge and Commissioner Henderson seconded. Motion carried 4 to 0.
- (13)Discuss and consider taking action by accepting the CTIF grant. PASS
- (14)Commissioner Kitchen made a motion to provide notice <u>not to renew</u> maintenance services provided by Edoc Technologies effective September 30, 2020 for the County Attorney's Office, District Attorney's Office, County Clerk's Office, and District Clerk's Office which was replaced by IDocket and authorize the County Judge to sign the notice. Commissioner Lovell seconded. Motion carried 4 to 0.
- (15)Commissioner Lovell made a motion to provide notice <u>not to renew</u> maintenance services provided by Image Tek effective October 31, 2020 for the County Clerk's Office and authorize the County Judge to sign the notice. Commissioner Kitchen seconded. Motion carried 4 to 0.
- (16) Discuss and consider taking action to declare Office of Emergency Management Envis Night Vision monocular as surplus property and donate to the Sheriff's Department for use by Houston County Search and Rescue. PASS
- (17)Commissioner Kitchen made a motion to accept as information the Fiscal Year 2019 Financial Statement and Audit Report for Houston County Emergency Services District No. 1. Commissioner Henderson seconded. Motion carried 4 to 0.
- (18)Commissioner Lovell made a motion to accept as information Houston County Appraisal District proposed budget for FY 2021. Commissioner Kitchen seconded the motion. Motion carried 4 to 0.

(19)Commissioner Lovell moved to accept a donation of fruit boxes from the Good Shepherd Fellowship Church for the Home Delivered Meal program to be distributed to clients. Commissioner Kitchen seconded. Motion carried 4 to 0.
