Jan Pigford explained the Health County Challenge to everyone.

Willie Kitchen made a motion to pay the invoice from Pineywoods Resource Conservation & Development Corporation and Gary Lovell made a second to the motion. Willie Kitchen gave an explanation of some of the projects of the Pineywoods Resource Conservation & Development Corporation. Kennon Kellum made a motion to award a contract from received bids for airport sales of AV Gas. Pat Perry made a second to the motion. Motion carried 5 to 0.

Gary Lovell made a motion, seconded by Kennon Kellum, to request a refund from the State Comptroller of unclaimed capital credits received from electric cooperatives in accordance with §381.004 of the Texas Local Government Code. Motion carried 5 to 0.

A motion was made by Willie Kitchen and seconded by Gary Lovell to accept as information Standard & Poors rating report for Houston County. Melissa gave an explanation of the report and stated that Standard & Poor upheld our bond rate. She explained that the report showed that the Commissioners' Court has done a great job with the finances of Houston County. The motion to accept the report as information carried 5 to 0.
