Judge Lovell recognized the guests and asked if there were any comments. There were no comments from the audience.

Gary Lovell made a motion to approve the prior Commissioners Court minutes. Willie Kitchen seconded the motion and the motion carried 5 to 0.

There were no budget amendments.

A motion was made by Kennon Kellum to change the Commissioners' meeting scheduled for the second Tuesday in December to Friday, December 21 at 10:00 a.m. due to the Christmas holiday. Willie Kitchen made a second to the motion. Motion carried 5 to 0.

Willie Kitchen made a motion to keep the Supplemental Retiree Medical Policy the same as last year. Gary Lovell made a second to the motion. Motion carried 5 to 0.

Willie Kitchen made a motion, seconded by Gary Lovell, to appoint Jo Smith as the Director of the Senior Citizens Center. Motion carried 5 to 0.

Gary Lovell made a motion, seconded by Willie Kitchen, to accept the Office of Court Administration's donation of eight desktop computers and a monetary donation of \$1,500 from

the Crockett Elks Lodge for the purchase of law enforcement supplies and two vests for the Sheriff's Department. Motion carried 5 to 0.

Danette Millican explained the need and cost for adding a mail slot for the Tax Office. Willie Kitchen made a motion to award the contract from received bids for installation of the mail slot in the front window of the tax office. The motion was seconded by Gary Lovell and the motion carried 5 to 0.

Willie Kitchen made a motion to accept a donation from Cedar Branch Baptist Church for improvements to County Road 2210 in Precinct 2. Kennon Kellum seconded the motion. Motion carried 5 to 0.

Melissa Jeter explained the current requisition policy and the possible changes to that policy. Willie Kitchen made a motion to make the change Melissa suggested. Gary Lovell seconded that motion. Motion carried 5 to 0.

An explanation of the proposed Houston County Fixed-Asset Policy was given by Melissa Jeter. She talked about the general policy; the capitalization policy, depreciation policy and other aspects of the fixed-asset policy.
