All interested persons are further advised that they have the right to employ an attorney and that if they or their attorneys fail to file a written notice with the clerk who issued this citation by 10:00 a.m. on the first Monday next following the expiration of 10 days after the posting of this citation, the Court may enter orders with binding effects upon said interested persons.

You are notified that you have the right under *Texas Estates Code* Section 1051.252 to file with the clerk a written request that you be notified of any or all specifically designated motions, applications or pleadings filed by any person, or by a person specifically designated in your request, relating to the application for the guardianship that has been filed or relating to any subsequent guardianship proceeding involving the ward after the guardianship is created, if any. If you make such a request, you are responsible for the fees and costs associated with furnishing you the documents specified in the request.

The officer executing this citation shall post the copy of this citation at the courthouse door in the county in which this proceeding is pending, or at the place in or near said courthouse where public notices customarily are posted, for not less than 10 days before the return day thereof, exclusive of the date of posting and return the original version of this citation to the clerk stating in a written return thereon the time when and the place where such copy was posted.
