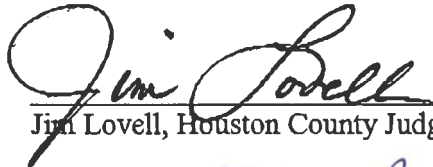
1. Welcome, Invocation and Pledges
