- (2) Discuss and consider action on awarding contracts from received bids for
 - a. Road Materials **Commissioner Lovell moved to award bid for Road Materials to all 3 bidders (Knife River Corp – South, Conners Construction, Frost Crushed Stone). Commissioner Stokes seconded. Motion carried 4 to 0.**
 - b. Hauling **Commissioner Stokes moved to award the bid for Hauling to Womack Trucking. Commissioner Henderson seconded. Motion carried 4 to 0.**
 - c. Gas/Diesel for County vehicles and equipment

d. AV Gas for Airport resale **Commissioner Henderson made a motion to award the bid for AV Gas to Bidder #3 – Campbell Oil, Bulk Delivery of Gas and Diesel (on and off road) to bidder #2 – First County Feed, and Gas/Diesel for County Vehicles at the pump to bidder #1 – Crockett Farm & Fuel. Commissioner Stokes seconded. Motion carried 4 to 0.**
