- (3) Consider approval of prior Commissioners Court minutes.

 Commissioner Stokes moved to approve the Commissioners Court Minutes from January 10, 2023. Commissioner Henderson seconded. Motion carried 5 to 0.

- (20) Discuss and consider action on authorizing the renovation of the office space located in the former JP building (112 E. Houston Ave), authorizing the move of JP 2 and Constable Precinct 2 from the Courthouse to the JP building and necessary budget amendments. Working on getting 3 bids/quotes for the work. Commissioner Stokes made a motion to designate as the Justice of the Peace Precinct 2 offices and authorize move from the courthouse to 112 E. Houston Ave., update flooring, paint, lighting, ceiling tiles, cabling and phones, use inmate labor for cleaning and demo, and authorize budget amendment of \$35,000 from contingency to pay for expenses. Commissioner Lovell seconded. Motion carried 5 to 0.
