- (2) Discuss and consider action on accepting the resignation of Detric Murray as full-time Houston County Sheriff's Department Patrol Sgt and approving part-time salary as Patrol Deputy.

  Commissioner Henderson made a motion to accept the resignation of Detric Murray as full-time Houston County Sheriff's Department Patrol Sgt. Commissioner Kitchen seconded the motion. Motion carried 5 to 0. Commissioner Kitchen made a motion to approve part-time salary of Detric Murray as Patrol Deputy at \$19.78 per hour in pay grade 20 effective August 29, 2023. Commissioner Henderson seconded. Motion carried 5 to 0.
- (3) Discuss and consider action on addressing the Cadet Employment Agreement for Kasey Ballard, Houston County Sheriff's Deputy and necessary action.
- (4) Discuss and consider action on accepting the resignation of Kasey Ballard as full-time Houston County Sheriff's Department Patrol deputy and approving part-time salary as Patrol Deputy. Judge Lovell announced the Court would consider Item 3 and 4 at the same time. Commissioner Kitchen made a motion to accept the resignation of Kasey Ballard as full-time Houston County Sheriff's Department Patrol Deputy and approve part-time salary as Patrol Deputy. Commissioner Lovell seconded. Motion carried 5 to 0. Commissioner Kitchen amended his motion to approve part-time salary of Kasey Ballard at \$18.50 per hour in pay grade 20 as part-time Patrol Deputy effective August 29, 2023. Commissioner Lovell seconded. Motion carried 5 to 0.
- (5) Budget Worship FY 2024 Budget. Workshop began at 9:15 a.m. and ended at 9:49 a.m.
- (6) Adjourn Judge Lovell made a motion to adjourn. The motion carried by everyone rising and leaving the meeting at 9:49 a.m.
