Commissioner Lovell made a motion to authorize the purchase and payment of a 2022 Ram 2500 Promaster Cargo Van for Houston County Aging Services from Henson Dodge Chrysler Jeep Ram at a cost of \$47,138.24, and that the budget be amended to cover the expense out of the American Rescue Plan Act (ARPA) Grant Fund.
