- (3) Consider approval of prior Commissioners Court minutes.

    year. Commissioner Kitchen seconded. Motion carried 4 to 0.

- Commissioner Kitchen made a motion to approve the salary of Zachary Allen as Full-Time Deputy at the Houston County Sheriff's Office at a bi-weekly wage of \$1,521.96 and bi-weekly phone allowance of \$18.46, in Pay Grade 20, effective September 26, 2023. Commissioner Lovell seconded. Motion carried 4 to 0.
- e. Transfer of Administrative Deputy to Lieutenant/Communications Supervisor

  Administrative Deputy to Lieutenant/Communications Supervisor, Full-Time, biweekly salary of \$1,923.08 with bi-weekly phone allowance of \$18.46, in Pay Grade
  24, effective October 1, 2023. Commissioner Lovell seconded. Motion carried 4 to 0.
- (8) Discuss and consider approving payment of compensatory, and vacation time for County Employees and necessary budget amendments. Commissioner Kitchen made a motion to approve payment of compensatory and vacation time for of Casey Proctor in the Sheriff's Office in the amount of \$841.56 and necessary budget amendments. Commissioner Kitchen seconded. Motion carried 4 to 0.
