Judge Lovell called the meeting to order and Gary Lovell gave the opening prayer. Judge Lovell led the pledges of allegiance.

Judge Lovell recognized the guests and asked if there were any comments.

Lonnie Ellis made comments concerning his precinct.

Gwen Scott from Precinct #3 questioned how the precincts prioritize projects and where she can go to find out what money is being spent where. Judge Lovell deferred a response to more experienced commissioner Willie Kitchen. Willie Kitchen made a motion to approve and confirm the salary of Belinda Hinson as Houston County Aging Director replacing retiree Evalena Ashley. Gary Lovell seconded. Motion carried 3 to 0.

Gary Lovell moved to approve the salary of Lois Netardus as Chief Deputy Treasurer replacing Janis Omelina who was elected as the new County Treasurer. The motion was seconded by Willie Kitchen. Motion carried 3 to 0.

Willie Kitchen made a motion to approve payment of compensatory, vacation and holiday time for previous County employees and necessary budget amendments. Gary Lovell seconded. Motion carried 3 to 0.

Judge Lovell said that he was going to throw Sharon Luker a curve on the power point and move to item 18 on the agenda. Mr. Duhon voiced his concerns about Willie Kitchen installing 2 speed bumps on CR 2345 in front of Vulcraft and feels there is no need for the speed bumps. Willie Kitchen invited Jeff Jeffcoat, Transportation Manager at Vulcraft, to speak to the need for the speed bumps. He gave a report on daily traffic at the intersection. Willie Kitchen voiced his major concern is to have a safe intersection.

Judge Lovell announced he would move back to item 9 on the agenda. Willie Kitchen moved to receive as information appointment of Chief Deputy County Treasurer, Chief Deputy County Clerk, and Chief Deputy District Clerk. Gary Lovell seconded. Motion carried 3 to 0.

A motion was made by Gary Lovell to receive as information appointment of Houston County Aging Director, Belinda Hinson. Willie Kitchen seconded. Motion carried 3 to 0.

A motion was made by Willie Kitchen to receive as information report of the Continuing Education Hours for Tax Assessor-Collector Office given by Danette Millican. Gary Lovell seconded. Motion carried 3 to 0.

Gary Lovell made a motion to appoint Tasha Brent to replace Mandy Patrick as the Houston County Wellness Coordinator for Texas Association of Counties statewide wellness initiative. Willie Kitchen seconded. Motion carried 3 to 0. Jan Pigford mentioned she is warning everyone that we will be starting back up in April with our first incentive (laughter).

There was discussion on approving the renewal of contract with Buell Sanitation for household/commercial garbage service for the southern part of the county. Willie made a motion to renew the contract and Gary Lovell seconded. Motion carried 3 to 0.

Gary Lovell made a motion to accept an anonymous donation in the amount of \$1000 for purchase of law enforcement equipment. Willie Kitchen seconded. Motion carried 3 to 0.
