A motion was made by Pat Perry to approve the part-time salary for Kenneth McClellan as Equipment Operator for Precinct #3. Gary Lovell seconded the motion. Motion carried 4 to 0.

Melissa Jeter, County Auditor, gave a short speech on the necessity of the Resolution Expressing Intent to Finance Expenditures to be Incurred by Houston County, Texas due to the bad weather and the extra expenses to maintain the roads in the county. Willie Kitchen made a motion to approve the Orders Authorizing Fireworks Sales on Texas Independence Day, San Jacinto Day, and Memorial Day. Gary Lovell seconded. Motion carried 4 to 0.

Gary Lovell made a motion that Commissioners Court acknowledge and sign "Order of Special Election to Legalize the Sale of Beer and Wine" to be held on May 4, 2019, in the district of Justice of the Peace Precinct 1. Motion carried 4 to 0.

Daphne Session, Houston County Attorney, spoke briefly about Rules of Procedure, Conduct and Decorum at Meetings of the County Commissioners Court. After hearing her address Roman Numeral IV specifically, Willie Kitchen moved to accept the Rules of Procedure, Conduct and Decorum at Meetings of the County Commissioners Court.
