 - b. Commissioner Lovell made the motion to approve the promotion of Arnita Cavendar from Intake/Discovery Clerk to Grand Jury Clerk/Crime Victim Coordinator in the DA's Office in Pay Grade 17 and a bi-weekly salary of \$1307.34. Commissioner Kitchen seconded. Motion carried 5 to 0.

 Ansel Bradshaw spoke about the tornado and how Vulcraft assigned employees to assist different areas that received damage in clean up. He bragged on the employees that assisted with the clean up and Vulcraft for bringing their own equipment, fuel, and even rented equipment all at their own expense. Ansel also wanted to recognize the company for the help and contributions in the community that most people are not aware that take place all through the year.
