Motion made by Judge Ford seconded by Willie Kitchen to define in the Houston County Employee Handbook resignation as voluntary separation of employment and approve holiday pay if the employee had to work in lieu of the holiday, regardless of separation type. Motion carried 5 to 0.

'Motion made by Willie Kitchen seconded by Roger Dickey to received bid in the amount of \$702.00 from Paul Caesar for lot 3, Block 15 being a part of the Smith Brothers Estate in the City of Crockett. Motion carried 5 to 0.

Motion made by Pat Perry seconded by Willie Kitchen to renew the contract with Buell Sanitation Service, LLC for household garbage service in rural areas of Houston County. Motion carried 5 to 0.
